



European Lighting Expert Re-Registration

Preface

In order to be permitted to bear the title "European Lighting Expert" also in future, every certified ELE must provide proof that his/her professional knowledge is based on state-of-the-art technology and the latest scientific findings five years after his/her registration. For this purpose he/she has the opportunity to renew the proof of qualification by means of a continuing education management with a point system during the years after certification.

The re-registration must be conducted and completed during year 6 after certification.

The Point system

During the **5 years** a total of **60 points** must be achieved, ideally **12 points per year**.

The maximum number of points that may be credited during **one year is 24 points**. Thus the required re-registration points can be achieved in a minimum of 2.5 years.

The last points (minimum 12 points) must be achieved **in the final year** prior to re-registration in order to assure that the ELE's knowledge is really based on the latest technical and scientific findings.

The points can be gained by means of different accomplishments and measures such as:

- Participation in continuing education measures
- Technical publications
- Lectures and presentations
- Realised projects

Any conventions/events used for gaining re-registration must have considerable professional (technical and/or specialist) content. The relevant information must be attached to the application for re-registration and must also be accepted by the national organisation.

Projects, technical publications, technical presentations and educational lectures etc. must be submitted to the national organisations and be appraised and accepted by them.

The point system is based on the assumption that for participating in relevant professional educational programs one point is credited for 2 tutorial units (ca. 2x45 minutes).

Subject to scope and coverage a maximum of 12 points may be credited for a realised project. In total a maximum of 30 points may be gained by realising projects.



For publications respectively lectures/presentations a number of points may be credited. This is subject to extent and content of the publication respectively the total time for giving presentations. The maximum number that may be credited for publications/presentations is 30 points, which is half of the total number points that must be achieved.

Participation at any educational activities must be certified by presenting a confirmation of participation or similar documentation.

All publications, activities related to presentations as well as projects must be supported by relevant documentation to be provided with the submission.

*) Project: In this context, "project" refers to projects related to light and lighting (lighting design, lighting controls/management, lighting concepts, reconstruction/retrofitting of luminaires, etc.) and should comprise of several performance phases (e.g.: concept, detailed design, realisation, commissioning, etc.).
